Bidding will be conducted in accordance to the International Competitive Bidding (ICB) Procedures as specified in the Public Procurement Act, 2015 and Public Procurement Regulation 2018.

Bidders must submit the following with their bid at the time of bid opening:

Eligibility Requirements for Local Suppliers

- 1. Local Contractors must be registered with *Public Procurement Commission (PPC) in Medical, Pharmaceutical Equipment and Supplies and/or Medical Equipment and Supplies"* category *and*
- Present a valid copy of the company Tax Compliance Letter (TCC/TCL). Letter must be supported with information pertaining to the expiry date of TCC.

Eligibility Requirements for International Suppliers

International Suppliers are required to submit a letter indicating their willingness to apply for the certification below should they be considered for the award of contract.

- 1. Public Procurement Commission (PPC) Certificate in Medical, Pharmaceutical Equipment and Supplies and/or Medical Equipment and Supplies" category and
- 2. Tax Compliance Letter (TCC/TCL).
