The **St. James Public Health Services** (a Statutory Body under the Ministry of Health & Wellness) is currently seeking to **employ a Parish Programme Specialist – Wastewater (HPC/EH 4)** for the **St. James Public Health Services**. Reporting to the Deputy Chief Public Health Inspector, the successful candidate will be expected to coordinate wastewater inspection services in the parish. The incumbent will also be expected to:

- ❖ Assess and determine the sanitary status of wastewater treatment systems to ensure compliance with standards and regulations.
- ❖ Monitor effluent quality routinely to ensure compliance with established standards.
- ❖ Collection and submission of wastewater samples for analysis during audits/special visits
- ❖ Monitor construction sites and inspect sewerage and drainage layout plans.
- ❖ Investigate complaints and take appropriate action.
- ❖ Enforce the provisions of the public health act and the requisite regulations to prevent or control the spread of waterborne diseases.
